

Last Will and Testament

I, __[Name]__, of the County of __[Name]__, State of California, do hereby make and declare this to be my Last Will and Testament and hereby revoke all former wills and other testamentary dispositions by me made. I have also been known as __[Name]__ and __[Name]__.

FIRST: I declare that I was formerly married to __[Name]__, that marriage having been dissolved in __[Year]__ and that I am not presently married. THIRD: I have purposely made no provision for any other person, whether claiming to be an heir of mine or not, and if any person, whether a beneficiary under this will or not mentioned herein, shall contest this will or object to any of the provisions hereof, I give to such person so contesting or objecting the sum of One Dollar and no more, in lieu of the provisions which I have made or which I might have made herein for such person so contesting or objecting.

FOURTH: My Executor shall represent any child under age eighteen (18) in matters relating to any distribution under this will, including selection of the assets that shall constitute that child's share, and my Executor may in my Executor's discretion sell for the child's account any part of that child's share. Any property or its proceeds distributable to a child under age eighteen (18) shall be delivered to the person acting as the guardian of the estate of that child.

FIFTH: I hereby nominate and appoint my friend, __[Name]__, of __[Address]__, __[City]__ California as the Executor of this, my Last Will and Testament, to serve without bond. If he should be unable or unwilling to serve, I nominate and appoint my __[relationship]__, __[Name]__, as alternate executor.
